

Pregnant, postpartum women severely affected in second Covid wave compared to first: ICMR study

New Delhi Astudy by the Indian Council of Medical Research (ICMR) has revealed that pregnant and postpartum women were more severely affected during the second Covid-19 wave in India as compared to the first, with case fatality rates and symptomatic cases being significantly higher this year.

Cases linked to pregnant and postpartum women during the first wave and second wave were compared in the ICMR study.

"Symptomatic cases were significantly higher at 28.7 per cent in the second wave (111/387), compared to the first wave (162/1143) when the proportion was 14.2 per cent," the apex research body said.

"The case fatality rate (CFR) among pregnant women and postpartum women was 5.7 per cent (22/387) during the second wave, which was significantly higher compared to the scenario encountered in the first wave with CFR 0.7 per cent (8/1143)," it added.

The study was conducted on 1,530 pregnant and postpartum women, which includes 1,143 from the first wave and 387 from second wave. The total number of maternal deaths during the first wave and second wave were 2 per cent (30/1530), of which the majority (28/30) were due to Covid pneumonia and respiratory failure. "The study underlines the importance of vaccination of pregnant and lactating women against Covid-19," the ICMR said.

Lactating women in India have been recommended to take the Covid-19 vaccine. However, the government is yet to allow these women to be vaccinated, citing lack of clinical trial data. The issue is currently being discussed by the National Technical Advisory Group on Immunization (NTAGI). Last week, the World Health Organisation (WHO) recommended vaccinating pregnant women if they have co-morbid conditions or face high risk of exposure to coronavirus.

Daughter of Ganga': Newborn girl found in wooden box floating in river

New Delhi. A newborn girl was found in a wooden box floating in the river at Ghazipur with a piece of paper that proclaimed her as the "daughter of the Ganga", according to a report. The box carrying the infant was found by a local boatman, Gullu Chaudhary, who carried the girl home. Besides the baby, the box contained a picture of goddess Durga, a horoscope and incense sticks.

After the matter was brought to the attention of the police, the child was admitted to the district hospital. Police said Gullu was at Dadri ghat on Tuesday evening when he heard the cries of the baby and found her alive in the box. Uttar Pradesh chief minister Yogi Adityanath took to Twitter to praise the boatman and said that the government will make arrangements for the upbringing of the child. The boatman who saved the life of a newborn girl has presented a unique example of humanity, he said. "As a token of gratitude, he will be benefited by all eligible government schemes. The UP government will make arrangements for the upbringing of the child," the CM said in a tweet in Hindi.

School reopening: Uttar Pradesh govt's primary, upper primary schools to reopen from this date



In view of declining COVID-19 infections in the state, the Uttar Pradesh government on Thursday (June 17, 2021) directed over 1.5 lakh government primary and upper primary schools to reopen from July 1.

New Delhi: In view of declining COVID-19 infections in the state, the Uttar Pradesh government on Thursday (June 17, 2021) directed over 1.5 lakh government primary and upper primary schools to reopen from July 1.

Pratap Singh Baghel, secretary, Basic Shiksha Parishad has reportedly issued an order to divisional assistant education directors and Basic Shiksha Adhikaris across the state. Though the schools will open for staff and teachers for administrative work, students will not be allowed to come till further orders from the Uttar Pradesh government. The schools in the state are reopening to conduct admissions for the new academic session and related work such as distribution of free books and maintenance of the building before the students come. Meanwhile, the online classes for students resumed last month. Now the teachers have been asked to conduct online classes from schools.

Additionally, the Basic Shiksha Parishad has also decided to deposit sanctioned money for mid-day meals directly in the account of students or their parents.

Delta plus variant may affect efficacy of COVID-19 vaccines to some extent: AIIMS Director Dr Randeep Guleria

New Delhi: AIIMS director Randeep Guleria on Wednesday (June 16, 2021) said that the delta plus variant of coronavirus may affect the efficacy of the COVID-19 vaccines available in the country but they will still be effective against the variant.

The AIIMS director revealed that the delta plus variant is not yet a concern, adding that "our main aim is to prevent deaths and serious illness".

As per a report in CNN-News18, Randeep Guleria also spoke about the issue of the increased duration gap between the two doses of the Covishield vaccine. The AIIMS director said that the current data analysed by the National Technical Advisory Group on Immunisation (NTAGI) revealed that the delay increases the immunity against COVID-19, adding that "as the data emerges, the authorities may change the protocol but as of now the data is quite solid on the current duration."

"When the data was evaluated, the alpha variant was dominant and it has changed,



the delta variant is more dominant now. Both variants are infectious, even the alpha variant was found more infectious than the previous variants. The data need to be looked at critically. Further decisions can be taken once the data is looked at critically and they look at it from the point of view of getting the crude data. It has to be taken after looking at the scientific evidence and can't be a knee-jerk reaction," Guleria added.

When asked about the current COVID-19

situation in the United Kingdom, which has vaccinated almost 62 percent with the first jab and fully inoculated 44 percent of its population, Guleria said, "We are always saying that vaccination has its limitation in terms of infection. I think we need to again understand what is the protection that the vaccine gives. To a large extent, the vaccine will definitely protect you from severe disease, in terms of hospitalisation or death. But the vaccine may not protect you that much from the infection. You may still get the COVID-19 infection but it may be milder or you may be asymptomatic and you will recover quickly because you have antibodies in your blood. You may be infected and may spread it to others but the virus will not multiply to the extent that it will cause a severe damage to your body."

The AIIMS director also added that the priority of the Indian government and

health experts is to prevent deaths and serious illness. "We will also decrease the number of cases but that may not happen at a larger extent than what we see as far as mortality is concerned," Guleria said. While addressing concerns over delta plus variant Guleria said, "Currently, the delta plus is a variant of interest. There is not much data to show that this is becoming dominant or this more infectious or causing more mortalities. Having said that, we need to see how this evolves, whether it remains a variant of interest or it becomes a variant of concern."

"Currently, the cases are few. It doesn't seem to be a major cause of concern. As far as delta variant is concerned, it is a variant which is more infectious, it is spreading rapidly. It is now taking over from where there was the alpha variant. Delta variant has become a variant of concern because it is spreading rapidly at a global level," he said while adding that the "vaccines have a multi-level immunity, so they still will be effective but their efficacy may come down to a certain extent."
