Bulandshahr: Woman raped, forced to undergo abortion, six booked

Bulandshahr Six people including a lady doctor were booked after a woman was allegedly raped and forced to undergo abortion in Uttar Pradesh's Bulandshahr

According to the police, the woman alleged that she was raped by her aunt's nephew who also forced her to undergo abortion.

According to the survivor's complaint, the accused allegedly raped her on multiple occasions after she went to her aunt's house in Khurja Dehat area in November 2019.

When the woman got pregnant, the accused allegedly brought her to his house in Bhatwara on June 29 this year and promised to marry her, police said. Later, the accused and his associates allegedly forced the woman to undergo an abortion, they said.

Cloudburst in **Uttarakhand's** Pithoragarh leaves 3 dead, 11 missing

Pithoragarh Cloudburst and heavy rains wreaked havoc in two villages of Uttarakhand's Pithoragarh district on Monday morning, leaving three people dead and as many injured.

At least nine people are reportedly missing after the cloudburst in Taga village of Munsiyari and Gela village of Bangapani in Pithoragarh district.The cloudburst has caused damage to many houses in the two villages of Pithoragarh. Three people have died in Gela village of Bangapani. In Taga, nine people are missing.

The rescue teams reached the two villages and launched a rescue operation. The search for the missing persons is underway.

Mumbai: Seven arrested for selling coronavirus drug remdesivir at Rs 30,000

Mumbai Mumbai Police arrested seven people of a gang on Saturday for selling one vial of remdesivir injection for Rs 30,000, which is six times more than the actual price of the coronavirus drug. According to a report in Hindustan Times, a police team sent a dummy customer to the gang after receiving a tip-off. Then they conducted raids and nabbed two accused from their homes and recovered seven injections.

The accused conspired to make easy money by procuring and selling the drugs at a higher price to needy customers," Akbar Pathan, deputy commissioner of police (crime branch) told Hindustan Times.

Officers from crime branch unit 7, along with the Food and Drug Administration (FDA) officials also seized 13 injections from the homes of the accused, identified as Rahul Bharat Gala, Vikas Angad Dubey, Bhavesh Ashok Shah, Ashish Gangadin Kanojia, Ritesh Rohidas Thonbare, Gurvindersingh Jasvindersingh Rathod and Sudhir Babu

In the investigation, it as found that Dubey and Vajpayee used to speak to each other at least 8-10 times daily. According to their call details, he was in constant touch with the gangster. He used to meet Dubey mostly at his Bikru village or at another flat in Kanpur. As per police sources, Vajpayee had celebrated the release of Dubey from a jail by carrying out airfiring, something which was opposed by the gangster's mother.

Vajpayee used to deal in cash with Dubey. He used to arrange cash on 3-4 hours notice, used to arrange cash of up to Rs 5 lakh for Dubey. Apart from cash money, he also used to arrange cars for the gangster and his gang members.

Jai Vajpayee is also believed to have invested money with Dubey in betting games too. Sources added that he worked as a conduit between Vikas Dubey and several IAS, IPS officers, ministers and legislators.

Coronavirus: Antibody tests at private labs indicate higher recoveries

New Delhi The sharp rise in coronavirus cases in the country is clear proof that the virus has spread to most parts, but data from private labs show the virus may not be as lethal as was feared earlier.

Many people have recovered from the virus in India without showing any signs of major symptoms, according to data from private labs that have been conducting

According to a report published in The Economic Times, antibody tests conducted by private labs in the country show that nearly 20 to 30 per cent of people that were tested had antibodies against the novel coronavirus.

Follow coronavirus live updates

It is worth mentioning that antibody tests are conducted to find out whether a person had been infected earlier. It helps in determining the spread and intensity of a disease in a particular area. Arokaiswami Velumani, the founder of Mumbai-based laboratory chain Thyrocare,



told the publication that the deaths per million in India is "very low" and that there is data to support the fact that many Indians have developed immunity against Covid-19 or SARS-CoV-2."We were wondering why deaths per million in India is very low, and we thought this is because we are testing less, but our data shows that a large number of Indians have developed immunity," Velumani told The Economic Times. Thyrocare has so far tested

65,000 samples across the country using a number of antibody kits. Their data showed that 15 per cent of all those tested had exposure to the novel coronavirus.

Most of these antibody tests were conducted on a voluntary basis and 80 per cent of these tests were conducted by corporates. About 15 per cent of such tests were conducted by residential societies and five per cent were undertaken by individuals, said

Meanwhile, Max Healthcare in Delhi told The Economic Times that 35 per cent of the people who took antibody tests showed traces of coronavirus but had already recovered.

While the increasing immunity to the virus is a good sign, the novel coronavirus has claimed over 28,000 lives in India and infected over 11.55 lakh people. There are over four lakh active cases in the country while over 7.2 lakh people have recovered.

Sikkim goes under complete lockdown, to remain shut till July 27



Kolkata The Sikkim government has decided to impose a complete lockdown in the state from July 21 to July 27 in view of the surge in the novel coronavirus cases.

The decision to impose the lockdown was taken after reviewing guidelines for the management of the Covid-19 situation in the state, a notification issued by Chief Secretary S C Gupta said."The last Indian state to contract Covid-19 is to go on complete lockdown with effect from 21st July (from 6 am) to 27th July (6 am)," the notification issued by the Sikkim Chief Secretary cited.Government offices, shops, commercial establishments, institutions, markets and factories will

remain closed except where a specific exemption is granted, the notification

Educational, training and coaching institutions will remain closed till August 31 next, it said. The notification added that all activities, congregations, movement of people and goods, passenger vehicles will remain prohibited or restricted except for exemptions granted by authorities.

Essential services will continue but the staff will have to follow strict norms of mask, gloves and carry their identity cards.

District magistrates will issue orders for enforcement of night curfew from 7.30 pm to 6 am on the lockdown days to restrict and regulate movement of people and vehicles and to ensure compliance with existing norms of social distancing, public hygiene and use of Arogya Setu application, according to the notification. Sikkim has reported 305 positive cases in two months. The first case was reported on May 23. There are 213 active cases, while around a hundred have recovered from the disease.

6-year-old seen pushing grandfather's stretcher in UP hospital, ward boy suspended: Officials

Gorakhpur Aviral video showing a six-year-old boy pushing a stretcher along with his mother to take his ailing grandfather from one ward to another in the adjoining Deoria district hospital in Uttar Pradesh has led to the removal of the ward boy as he allegedly demanded Rs 30 for every trip of the service.

The ward boy of the hospital's surgical ward was removed after the eight-second video, in which the boy is seen pushing the stretcher and his mother pulling it, caught the attention of Deoria district magistrate who visited the hospital and ordered a probe into the episode, said officials on Monday. The old man's daughter Bindu told reporters that the ward boy was demanding Rs 30 each time for taking the stretcher to the ward for the dressing of her father. Officials said Chedi Yadav of Gaura village under Barhaj area in the district had been injured two days ago and his family members admitted him in the surgical ward of the hospital.

His wife Parvati being too weak to attend on her husband, the old man was being attended by his daughter Bindu Yadav and her son, they said. "Hospital staff was asking Rs 30 every time for pushing the stretcher to the ward for the dressing of my father and when I refused to give him the money, he refused to push the stretcher, so I had to drag it with the help of my son Shivam," Bindu told

ew Delhi The Centre has written to all states and union territories warning against the use of N-95 masks with valved respirators by people, saying these do not prevent the virus from spreading out and are "detrimental" to the measures adopted for its containment. he Director General of Health Services (DGHS) in the Ministry of Health, in a letter to the Principal Secretaries of health and observed that there is "inappropriate use" of N-95 masks, particularly those with valved respirators, by the public other than designated health workers.

In view of the above, I request you to instruct all concerned to follow the use of face/mouth cover and prevent inappropriate use of N-95 masks," DGHS Rajiv Garg said in the letter. The advisory stressed such face covers must be washed and cleaned each day, as instructed, and stated that any used cotton cloth can be used to make this face cover. Adding salt to fits the face well and there are no gaps urges people to wash hands thoroughly before wearing the face

cover, switching to another fresh one as the face cover becomes damp or humid, and never reusing it after single use without cleaning it. "Never share the face cover with anyone. Every member in a family should have separate face cover," the
